Do export controls apply if a company launches a satellite?

Additional export controls will also apply should a company's export be related to the launch of a satellite, if the launch takes place from a non-NATO country (unless the country is a major non-NATO ally).¹³ Likewise, if the launch is conducted by nationals of such a country, then these additional controls would apply.

What do exporters need to know about FMS & DCS?

Whether selling via FMS or DCS, exporters must understand how the product in question is controlled and what licenses or authorizations one may need to export. A more comprehensive look at the roles of the Directorate of Defense Trade Controls and the Bureau of Industry & Security The ITAR sets out regulations for items on the USML.

The Department of Commerce's website ([www.dhs.gov](#)) is the final authority on Export Administration Regulations (EAR). All companies should consult the State Department and Department of Commerce to ensure they have the most recent information.

Are DoD shipments exempt from export license requirements?

Most DoD shipments are exempt from Department of Commerce export license requirements. License requirements are dependent upon an item's technical characteristics, the destination, the end use, and the activities of the end user.
