How did tariffs affect solar panel exports?

Following the initial tariffs in June, solar panel exports from Vietnam, Malaysia, Thailand, and Cambodia to the US decreased by 33% year-over-yearover the subsequent nine months. During this same period, trade data indicates that exports from neighboring Indonesia and Laos saw an approximate eight-fold increase.

Are US solar panels at risk from China's tariffs?

US-manufactured solar panels, which use upstream material from China, might see the largest cost increases given the steeper duty rates and a lack of supply chain outside of China. Battery Energy Storage Systems (BESS) are at even higher risk of substantial price increases due to tariffs, given China's control over the BESS supply chain.

Why do solar panels have a 25% tariff?

For example,25% tariffs on steel and aluminum are felt not only by racking suppliers but also solar panel manufacturers as frames are typically made of aluminum. Outside of cells,frames are the single most expensive sub-component in a solar module,so a 25% duty may increase the cost by a few cents per watt on American-made solar modules.

Is the solar industry insulated from tariffs?

Although the cost to install solar in the United States is higher than elsewhere in the developed world, the industry continues to grow in the U.S. The good news is that there has been significant investment in solar manufacturing in the U.S., so the industry is somewhat insulated from the impact of tariffs.

How much will a tariff on solar cells increase in 2024b?

The tariff on solar cells has risen from 25% to 50%, and battery cells have seen increases up to 25%. Today, importing solar cells from China, which cost between a few cents to a nickel per watt, would see a tariff increase from \$0.0125/Wdc to \$0.025/Wdc with this hike. 2024b - Pending Investigation
